In compliance with California Public Utilities Code Sections 454.51 and 454.52, the September 24, 2020 Scoping Memo,¹ and Administrative Law Judge (“ALJ”) Fitch’s April 9, 2021 and July 8, 2021 email rulings, San Diego Community Power (“SDCP”) hereby submits its 2021 Integrated Resource Plan (“IRP”) Procurement Data Update.

I. SDCP’S PROCUREMENT DATA UPDATE

SDCP’s Resource Data Template version 2 (“RDTv2”) contains SDCP’s updated electricity procurement data. Since SDCP was not assigned a procurement obligation in D. 19-11-016, SDCP is not required to report progress towards meeting the electric capacity procurement requirements set forth in that Decision.

The public, redacted version of SDCP’s RDTv2 is included as Attachment A. In accordance with the Filing Requirements Overview, the confidential, unredacted version of SDCP’s RDTv2 has been submitted through the Commission’s secure File Transfer Protocol (“FTP”) website and SDCP has filed a motion for confidential treatment of portions of SDCP’s RDTv2.
